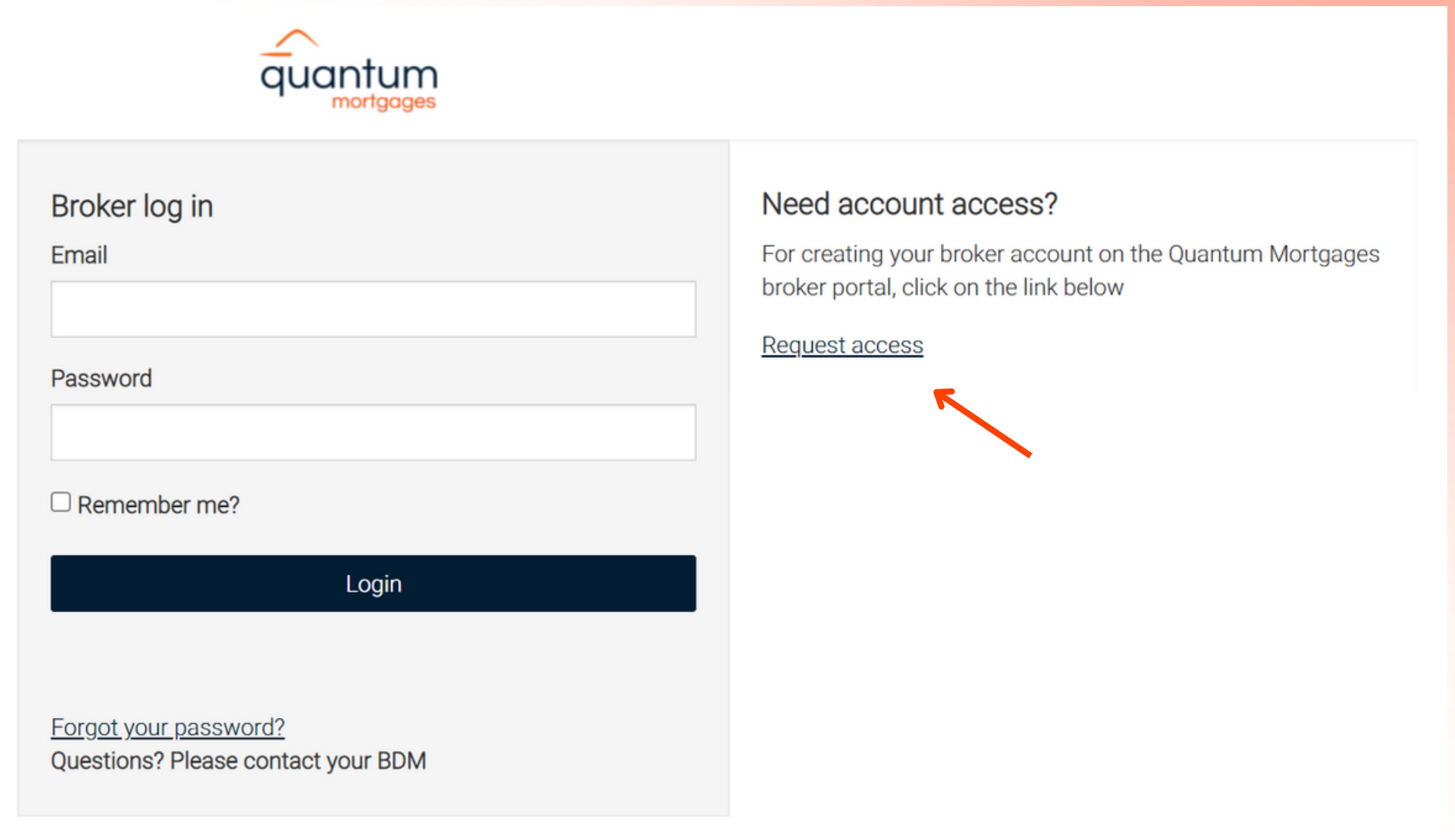

Site Use Terms And Conditions

Mortgage Intermediary Terms of Business

These Terms of Business set out the conditions under which you, an Intermediary, are to submit mortgage applications as a Directly Authorised Intermediary, Principal, Appointed Representative, Approved Packager and/or Distributor to Quantum Mortgages Limited ('Quantum Mortgages or the Company')

When each application is submitted to us you agree to these Mortgage Intermediary Terms of Business ('Terms').

We reserve the right to alter these Terms at any time and your continued submission of applications will be taken as acceptance of the revised Terms.

How the Terms apply?

1. If you are an Appointed Representative and your Principal has entered into a Mortgage Intermediary Agreement with us.
2. If you are a Principal and you have entered into a Mortgage Intermediary Agreement with us.
3. If you are a Directly Authorised firm and have entered into a Mortgage Intermediary Agreement with us.
4. If you are an Approved Packager or Mortgage Club and your Intermediary has entered into a Mortgage Intermediary Agreement with us.

Note for Appointed Representatives

If you are an Appointed Representative, we and your Principal (commonly referred to as a 'network') may have entered into an agreement ('Mortgage Intermediary Agreement') with us governing the legal terms applicable to any introduction by you of mortgage applications to us. It is your responsibility to ensure that your Principal had advised you of the terms of any Mortgage Intermediary Agreement which apply to you. By entering into these Terms, you agree to comply with all terms of the Mortgage Intermediary Agreement which apply to you.

Intermediaries will only be able to submit applications to Quantum Mortgages where a Mortgage Intermediary Agreement has been entered into with the Company.

1. Definitions

'Applicable Regulations' means all laws, regulations, orders, directions from regulators and industry codes of practice applicable to the sale, marketing or variation of mortgages and related products in the UK, including without limitation, the FSMA, the FCA Handbook, the DPA, GDPR, the CCA, the Advertising Standards Authority British Code of Practice. N.B. If you are the first person from your organisation to register with Quantum Mortgages you will have administration rights, so can send links to another team member for them to register on the portal.

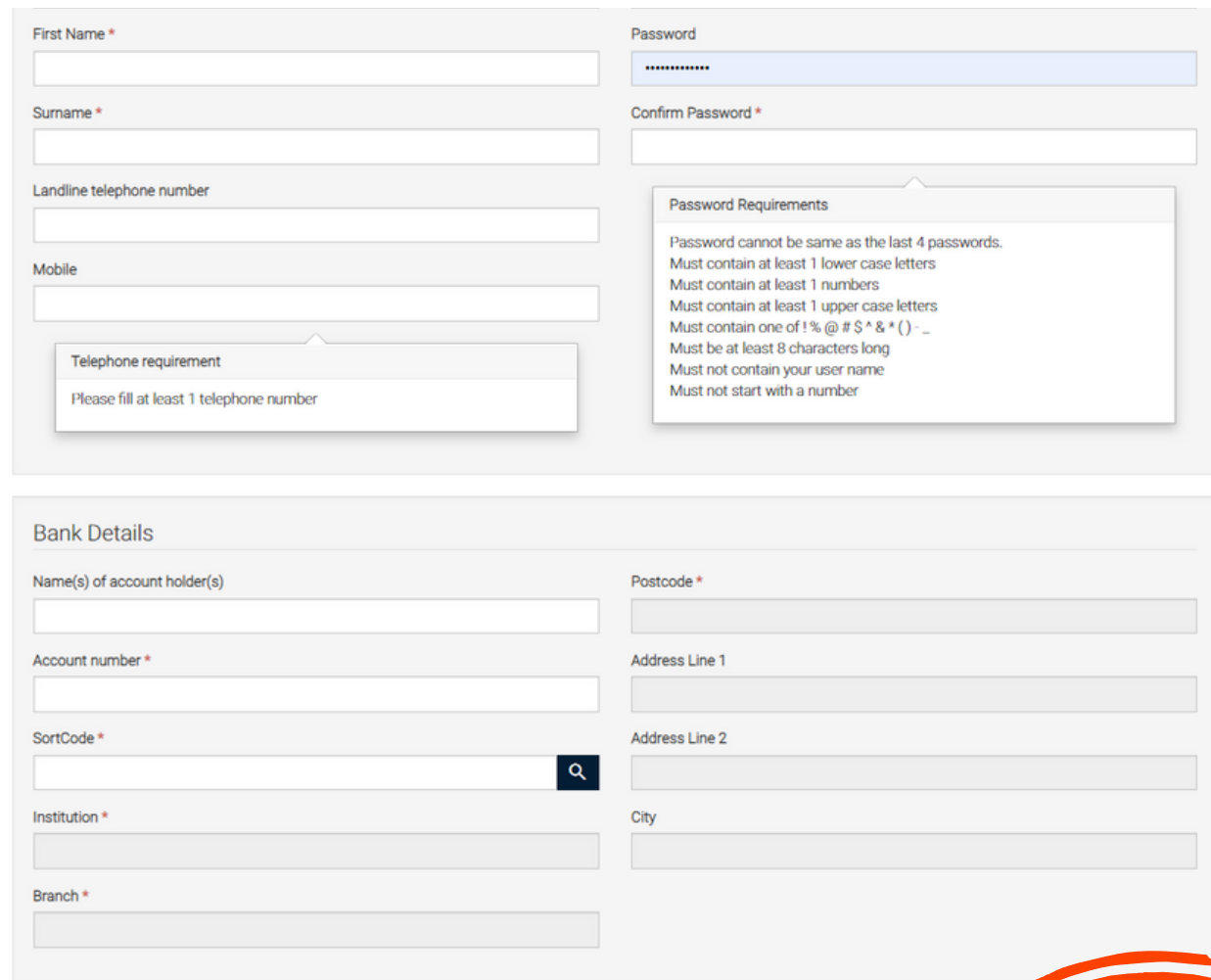

The bank account details entered will be used to pay proc fees on completion of loans (unless a mortgage club payment route is selected when submitting an application).

Note: if you are an Appointed Representative of a Directly Authorised firm then you need to complete the bank details of your Principal as this will need to be the firm that Quantum Mortgages will pay.

Click request access.

An email will then be sent to the registered email address for you to verify. Please click on the link once received. We will then process your request and confirm access has been granted by email within 48 hours.

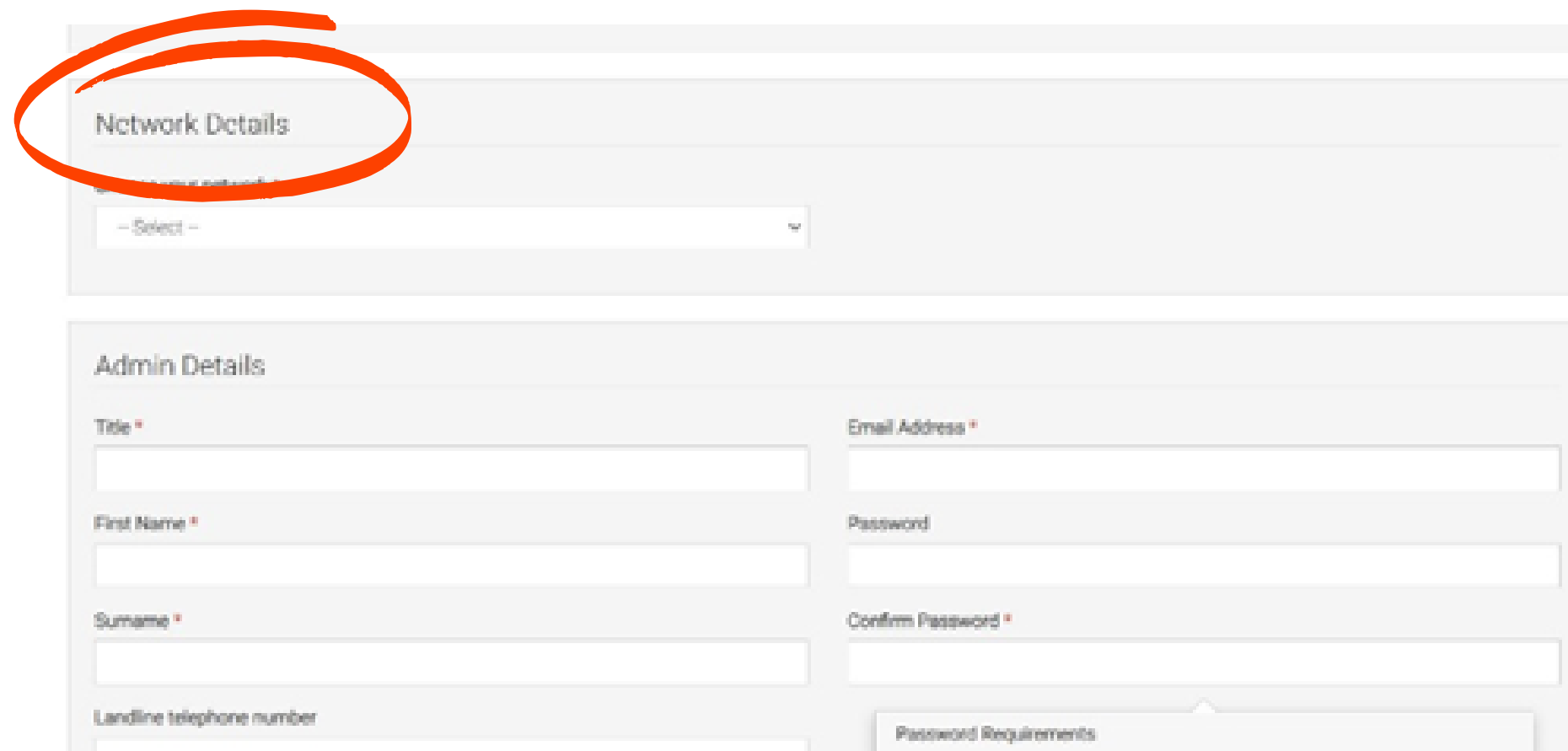

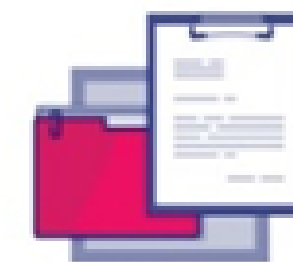
